Interested consultants must provide information (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). to prove beyond reasonable doubt that they are qualified to perform these services. Consultants may form joint-ventures to enhance their chances of qualification.

Eligibility criteria, establishment of the short-list and the selection procedures shall be based on the African Development Bank's "Rules and Procedures for the use of Consultants" May 2008 Edition which are available on the Bank's website at http://www.afdb.org. The consulting firm must demonstrate experience in the following areas:

- A minimum of 10 years of experience in medical equipment planning, procurement, installation, supervision and commissioning within healthcare facilities.
- Proven track record in handling large-scale hospital equipment procurement and installation projects, preferably for tertiary hospitals or specialized cardiac centres.
- Experience working with international donors, such as the African Development Bank (AfDB), World Bank, or other multilateral financing institutions, adhering to their procurement guidelines for at least three projects.
- · Successful completion of at least three (3) similar assignments in the past [5] years, with documented evidence of performance.
- Experience in training healthcare professionals on equipment operation, maintenance, and quality assurance.
- Strong knowledge of regulatory and compliance standards for medical equipment, including ISO, WHO, and national health regulations.
