1.0 MUHIMBILI UNIVERSITY OF HEALTH AND ALLIED SCIENCES (MUHAS)

The Muhimbili University of Health and Allied Sciences (MUHAS) is a Tanzanian Premium Health and Allied Sciences University established in 2007 through Article 1 of the Charter of Incorporation in line with the Universities Act No 7 of 2005. Since its establishment, MUHAS has managed to have a range of programmes in biomedical, clinical and allied health sciences which necessitates increasing of number of staff to perform its intended function. In this context, MUHAS is inviting applications from suitable candidates for various posts as itemized below for teaching the programmes across seven Schools and one academic Institute of the University.

1.1 JOB SUMMARY

Muhimbili University of Health and Allied Sciences (MUHAS) in collaboration with Bergen Centre of Ethics and Priority Setting in Health (BCEPS) at the University of Bergen are implementing a five-year project funded by NORAD: *Fair Choices on the Path to Universal Health Coverage (UHC) 2020–2030*. The project aims to support institutional capacity building in Health Economics, Priority Setting and Health Technology Assessment, hence, directly contributing to improved health outcomes for the Tanzanian population. The project will focus on:

Strengthen country capacity: Enhance the ability of national institutions in Tanzania to translate evidence-based priorities into actionable health system reforms. This includes improving the transparency of priority decisions, enhancing the use of economic and equity analysis, and establishing inclusive deliberative processes.

Institutionalisation of Fair choices tool: Embed evidence-informed priority setting as a core function within Ministries of Health through the use of fair choices tool in generating evidences for decision making.

Strengthen Global Networks: Expand partnerships with international health agencies (such as WHO and the World Bank) and leading academic institutions to amplify the project's impact, share best practices, and contribute to a global community of practice.

The project seeks a qualified and motivated Project Coordinator and Fair choice Data Analyst Lead to be based in Dar es Salaam, to support effective coordination, implementation and analysis of project activities at the country level.

1.1.2 TYPE OF EMPLOYMENT

This is a full-time contractual employment for a period of One years.

2.1 PROJECT COORDINATOR II - 1 POST

- (ii) Develop, track, and update project work plans, timelines, and deliverables;
- (iii) Support organization of meetings, workshops, trainings, and stakeholder engagement activities;
- (iv) Facilitate effective communication and coordination between national teams, regional partners, and international collaborators;
- (v) Monitor project progress and contribute to timely technical and donor reporting;
- (vi) Support administrative and financial processes in collaboration with finance and procurement units;

- (iv) Annual/Quarterly review workshops to assess the implementation of Fairchoices, HTA, and UHI strategies.
